In front of you is a coming-together of more than 100 experts from more than 25 countries from the sub-region and others from outside Africa. Participants come from Kenya, Uganda, Rwanda, Mozambique, Zimbabwe, Lesotho, Sierra Leone, Nigeria, Angola, Botswana, Namibia, Republic of South Africa, Egypt, Sudan, Ethiopia,

Eritrea, Ghana, Togo, Slovenia, Canada, United States of America, the United Kingdom and India.

This workshop has been sponsored by UNEP/GEF to provide a forum for sharing experiences among the Anglophone African Countries regarding the development of National Biosafety Frameworks for the implementation of the Cartagena Protocol. As you are aware the Cartagena Protocol on Biosafety to the Convention on Biological Diversity was finalized and adopted in Montreal in January 2000 and entered into force on 11th September 2003. Tanzania acceded to the Protocol on 16th March 2003. The main objective of the Protocol is to ensure safe development, handling, transport, use, transfer and release of any GMOs into the environment while at the same time preventing risks to both the very environment and human health taking into account social-economic, cultural and ethical concerns.

Your Excellency,

Tanzania is one of the countries involved in the UNEP- GEF Biosafety Project in the development of National Biosafety Frameworks in order to meet the Cartagena Protocol obligations. Tanzania through Your Office with the support of UNEP-GEF in collaboration with stakeholders country-wide, launched a process for developing a National Biosafety Framework for the implementation of the Cartagena Protocol on Biosafety in September 2002. The process involves establishment of a system of legal, technical, and administrative mechanisms to address safety in the field of modern biotechnology. The development of our National Biosafety Framework (NBF) commenced with the formation of National Coordinating Committee that is comprised of members from relevant ministries and institutions. Members of the National Coordinating Committee are from Tanzania Mainland and Zanzibar.

Your Excellency,

Todate, a country report on Biosafety and Biotechnology, draft regulations on Biosafety and draft Biosafety Guidelines have been prepared.

At this workshop, resource persons will provide a brief account of UNEP-GEF Biosafety Projects; they will present a synthesis of regional experiences based on country progress reports and they will describe national obligations and rights under the Cartagena Protocol. Participants will deliberate on key issues arising from these presentations and from case studies earmarked for this workshop.

I am confident that this sub-regional workshop will further enhance our understanding of the issues in the implementation of the Biosafety Protocol and improvement of the draft documents.
